7.0 PRESENTATIONS

1st Speaker – Mr. Austin A. Gamey, FCIHRMP, M.A. Adr (PULSE) Ca. A.I. (USA)



CEO, Gamey and Gamey Group, Labour and ADR Consultant. Tema – Ghana. The speaker, Mr. Austin A. Gamey, expressed gratitude for the invitation to speak at the CIAMC conference on the topic of **"Discretionary Powers, Duty Imposed, the Law, and the Administrator."** He noted the timeliness of discussing this subject in light of the various economic, technological, and social challenges facing the country. Mr. Austin Gamey expressed his gratitude for being invited to speak at the conference on the topic of **"Discretionary Powers, Duty Imposed, the Law, and the Administrator"**. He noted the significance of discussing these issues, especially given the country's current economic, technological, and social challenges.

He highlighted the historical context of administrative management, noting that until the late 1970s, administrative managers were primarily

responsible for overseeing various aspects of administration. He also mentioned the official transition of job titles from personnel managers to human resource management in Ghana in 1998.

Mr. Austin Gamey emphasized the need for a transition towards appreciative leadership in light of rapidly changing technologies and the importance of enhancing knowledge and skill development. He



described appreciative leadership as a paradigm shift away from traditional command-and-control practices towards valuing and empowering individuals to maximize their potential.

He referenced Article 36 of the 1992 Constitution, which outlined the state's responsibilities to maximize economic development, welfare, and employment opportunities while safeguarding the health and safety of workers.

Mr. Gamey stressed the importance of free choice in empowering individuals and fostering organizational excellence and positive change. He emphasized that people perform better and are more committed when given the freedom to choose how they contribute to the organization's goals.

Overall, his speech underscored the importance of effective leadership and the role of administrators in driving positive change and organizational success.

2nd Speaker - Ms Afua Brown-Eyeson explored the area of "Landed property procurement, Contract Negotiation, and Conveyance."



Ms. Brown-Eyeson shed light on a subject of great importance—land acquisition and property ownership and delved into various facets of this intricate domain, encompassing procurement methods, interests in land, due diligence, and contract negotiation.

Firstly, she explored the diverse methods employed in procuring land, ranging from individual endeavors to government initiative and highlighted the different interests one can hold in land, be it allodia property, freehold, leasehold, or usufructuary interests, each holding its own significance in the realm of property rights.

Moreover, she underscored the meticulous process of due diligence, where we evaluate title deeds, conduct searches, and verify the authenticity of

ownership documents. Contract negotiation, a crucial aspect in any land transaction, was also elucidated, highlighting the importance of clarity and precision in contractual agreements.

Also, she navigated through the legal intricacies surrounding land acquisition, including the implications of compulsory acquisition and the concept of good title, payment terms, contracts of transfer, and the responsibilities of entities managing communal lands was also examined in detail.

Furthermore, she lamented the challenges posed by land guards and the necessity for restraining orders to maintain order and protect legitimate landowners. She also touched on inherited property checklists, emphasizing the importance of proper documentation and legal compliance in property inheritance.

In conclusion, she urged all to grasp the significance of the topics discussed as stakeholders in various capacities, whether as administrators, executives, or heads of institutions, it was imperative to navigate the realm of land acquisition and property ownership with diligence, integrity, and a profound understanding of the legal framework governing these transactions.

3rd Speaker – Hon Sam Okudzeto, SAG, MOV FChPA, FCMC, Member of the Council of State and Senior Partner at Sam Okudzeto & Associates



Hon. Sam Okudzeto explored the theme **"The Law of Meetings"** The presentation by Hon. Sam Okudzeto, covered the various aspects of corporate meetings, corporate governance rules, and procedures to be followed during these meetings.

He discussed the importance of meetings for decision-making in companies and outlined the types of corporate meetings, such as general meetings and board meetings. He emphasized the necessity for proper notice, procedure, and adherence to corporate governance rules during these meetings.

Mr. Okudzeto explained the roles of the chairperson and the secretary in conducting meetings, maintaining order, and recording minutes. He underscored the importance of minutes as a written record of meeting

proceedings, which must be kept at the company's registered office for inspection by members.

Additionally, Mr. Okudzeto highlighted the significance of resolutions, both ordinary and special, which are used to make major corporate decisions. He explained the difference between ordinary and special resolutions and the requirement to file special resolutions with the Registrar of Companies within a specified timeframe.

In a nutshell, he elaborated on written resolutions, which may be used when members or directors are unable to physically meet. These resolutions require unanimous agreement from all parties involve and are effective upon the last member's signature. However, Mr. Okudzeto noted that written resolutions cannot be used to remove an auditor or a director.
